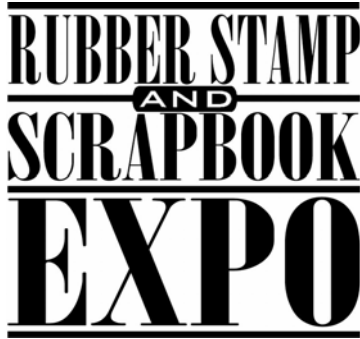

All merchandise and personal property is the sole responsibility of the exhibitor. RUBBER STAMP & SCRAPBOOK EXPO, INC. or HOLIDAY INN SELECT – TINLEY PARK CONVENTION CENTER will not be held responsible for lost, stolen or broken goods before, during, or after the event; nor will the above be responsible for any personal injury before, during or after the event. In the event of cancellation of the show due to fire, strikes, act of God, government regulations, or any cause beyond control, Management shall determine an equitable basis for the refund of such portion of Entrance, Publicity, Directory and Exhibit Fee as possible, after consideration of expenditures and commitments already made. Refunds shall be made solely at the discretion of Management. A \$50 processing fee will apply to all cancellations regardless of cancellation date. Under all circumstances, Management retains the right to sell any space cancelled by exhibitor. No spaces may be shared or sublet. Deposits are non-refundable.
